The munificent founder of Ponnaiyah Ramajayam Institute of Science and Technology (PRIST), Prof. P. Murugesan, began his service to higher education in this predominantly agricultural area by establishing Ram Institute of Computer Science and Technology in the year 1985. At that time, his very purpose of establishing that institute was to introduce Computer Education for the first time in Thanjavur District, Tamil Nadu. In 1988, the Institute got affiliation from Bharathidasan University to offer Post Graduate Diploma Programme in Computer Applications.

Prompted by the encouragement and support extended by the stakeholders and by and large by the public, he has established Ponnaiyah Ramajayam College affiliated to Bharathidasan University, Tiruchirappalli, in the year 1994, in memory of his father Sri Ponnaiyah and his

The very first batch of students has secured a Gold Medal and 4 University Ranks for the college. Ponnaiyah Ramajayam College has gone for NAAC assessment and accreditation in the year 2004 and has been awarded “A” grade (the first “ A “ Grade awarded college in the Bharathidasan University area) and there by projected itself distinctly in the field of higher education. Based on the recommendations of the UGC Expert Committee, the Ministry of HRD, Government of India, has conferred Deemed University status to the institution in the name of Ponnaiyah Ramajayam Institute of Science and Technology (PRIST), through its order dated 4<sup>th</sup> January, 2008.

The institution has gone for NAAC accreditation in October 2015 and has secured a CGPA of 2.95.
