The Deemed to be University has started off-campuses at Trichy, Kumbakonam, (111) Madurai, Puducherry and Chennai without the approval of the Ministry of HRD. This matter is sub-judice before Hon'ble Madras High Court.

You are requested to submit clarification in respect of the above to the UGC and Ministry of

HRD.
