





13/12/2021 SEMINAR ON LEGAL RIGHTS FOR WOMEN



TALK ON "WOMEN PROTECTION AND LAW" FOR GIRL STUDENTS AND

LADY STAFF

On March 29, 2019, an enlightening talk on "Women Protection and Law" was held in the PRIST Seminar Hall from 10:30 AM to 12:30 PM. 
